*The meeting was called to order at 7:00 pm by Mayor Stonum with motion by Commissioner Metcalf and seconded by Commissioner Recendez. The Pledge of Allegiance to the Flag of the United States was recited; followed by a moment of silent prayer.*

**Minutes:** *The November 2025 minutes were brought up for approval. Motion was made by Commissioner Beville to approve the minutes and seconded by Commissioner Metcalf. Vote was unanimous.*

**Financial Report:** *The November 2025 Financials had been distributed to the Commission for review and posted on COWH website prior to the City Meeting. Motion to approve was made by Commissioner Beville and seconded by Commissioner Recendez. Vote was unanimous.*

**Expense Review:** *The cover sheet of December invoices along with invoice copies were passed around for Commissioners to review and initial. No approval motion was needed since Commissioners had already initialed and approved*

**Legal:**

- *Unclaimed funds from Ky Treasurer. Treasurer Small prepared and read a letter to the Ky Treasurer to authorize Treasurer Small to submit a claim form on behalf of COWH. A motion was made to approve the letter by Commissioner Metcalf and seconded by Commissioner Recendez. Vote was unanimous.*

- *Adjustment of the Commissioners' Pay:*
  - o *Deadline for the Ordinance to be passed is May 1, 2026 to be effective January 1, 2027. After some discussion, Mayor Stonum suggested increase of \$50 or \$100 per month. Mayor Stonum will create amendment for the \$100 figure and have the first read at the January meeting.*
- *Welcome Ambassador – no change/update*
- *Commissioner Metcalf advised we will be using Channel 11 tonight for radio check.*
- *City Clerk Lush:*
  - o *2 streetlights still out on Dickerson Court. Commissioner Maupin has checked with LG&E and they are still awaiting parts.*
  - o *Westport Road entrance has a spotlight that is out. Mayor Stonum advised that COWH is responsible for fixing that light and it will be fixed in the spring.*
