Holidays Decorating Contest and Judging Entry Form Drawing Winners' Names & Addresses to be posted on the City's Website after 5 PM on December 27, 2019

Rules:

1. Contest will be open to all properties located within the City of Worthington Hills
2. **Only one prize will be awarded per property and/or household.**
3. There are three (3) categories:
 - a. Outside Holiday Decorations – Exterior Holiday Displays
 - b. Window(s) Holiday Decorations Only – Home's Window Holiday Display
 - c. Judging Entry Form Drawing – Only City of Worthington Hills residents are eligible

Outside Holiday Decorations and Window(s) Holiday Decorations prizes will be awarded as follows:

1. Property address can only be submitted once on the Judging Entry Form for either of the two Holidays decorating categories.
2. At least two (2) City Commission members will confirm the winning properties, which have received votes for Outside Holiday Decorations or the Window(s) Holiday Decorations, have displayed Holidays Decorations within the category for which a prize is being awarded.
3. The “**Outdoor Holiday Decorations**” 1st, 2nd, and 3rd Places will be determined by highest number of votes cast for eligible properties in this category. (Address placement on the submission form does not determine prize level.)
4. Award levels or prize amounts in this category will not be split.
 - a. Ties within this category will be resolved by drawing(s) performed by the City Clerk in the presence of at least one elected Commission member for the appropriate award level(s) and prize amounts. Tie breaker drawing(s) will be conducted as follows:
 - i. 1st Place tie vote drawing involving 2 or more properties. First drawn address determines 1st Place winner, second address drawn determines 2nd Place winner, and 3rd address drawn determines 3rd Place winner. (1st, 2nd, & 3rd Prize Awards completed.)
 - ii. No tie vote drawing for 1st Place, but 2nd Place involves 2 or more properties. First drawn address determines 2nd Place winner, second address drawn determines 3rd place winner. (2nd, & 3rd Prize Awards completed.)
 - iii. No tie vote drawing for 1st or 2nd Place, but 3rd Place involves 2 or more properties. First drawn address determines 3rd Place winner. (3rd Prize Award completed.)
4. The “**Window(s) Holiday Decorations Only**” winner will be determined by highest number of votes cast for an eligible property in this category.
 - a. A tie will be resolved by a drawing performed by the City Clerk in the presence of at least one elected Commission member.
 - i. First drawn address determines winner in this tie vote drawing.

Judging Entries

1. Judging and entry period:
 - a. Starts 12:01 AM December 20th
 - b. Ends 11:59 PM December 24th
2. Non-Residents of the City of Worthington Hills are ineligible to judge or win.
3. Only one (1) Judging Entry per email address per day will be counted.
4. **Only one (1) Judging Entry per email address will be entered into the drawing.**
5. Judging Entries submitted from a winning address for either of the Decorating Contests are ineligible.
6. Incomplete or inaccurate information on the Judging Entry form voids eligibility to win in this category.
7. Judging Entry will be a random pick of the eligible entries received.
8. The City Clerk will perform the random drawing of the eligible entries in the presence of at least one elected Commission member.
9. Judging Entry Form drawing winner must provide adequate proof of City of Worthington Hills residency to receive prize.
